Terms and Conditions 1. Group Social Support and Respite are charged per hour if less than three hours, otherwise charged per session. 2. Meals (Centrebased) charged if a standalone service. Not charged when meal part of a group session. 3. Cottage respite and In-home overnight respite are charged per night. 4. Weekend and Public Holiday rates apply for services at any times on these days. 5. After Hours rates apply for service between 6pm and 6pm on any other days. 6. Daytime rates apply for services between 6am and 6pm on any other days. 7. Medication, equipment hire and other consumables are not included in the above rates. 8. Scheduled services cancelled later than 11am the day before, or shortened at the request of the client, will still be charged based on the full length of the planned visit, the exception being in circumstances beyond the control of the client, such as illness. For visits longer than the scheduled length, additional charges may apply. 9. Minimum visit times are 15 minutes
